Notice is hereby given that the Secretary of State has accepted an application ("the application") by INRG Solar (Little Crow) Ltd of 93 Leigh Road, Eastleigh, Hampshire, S050 9DQ ("the applicant") for a Development Consent Order under the Planning Act 2008. The application (Reference EN010101) was submitted on behalf of the applicant to the Secretary of State c/o the Planning Inspectorate on 4 December 2020 and was accepted on 23 December 2020.

The application site is located to the east of the British Steel Works, Scunthorpe, DN20 0BG.

PROPOSED DEVELOPMENT

The development proposal relates to the construction, operation, maintenance and decommissioning of Little Crow Solar Park, a renewable led energy scheme. The main elements of the development will be the installation of ground mounted solar panels with an intended design capacity of over 50MWp (megawatts peak) covering an area of approximately 225 hectares. There will also be electrical connection infrastructure.

The proposed works are environmental impact assessment development for the purposes of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 and accordingly an Environmental Statement accompanies the application (this is labelled as document reference numbers 5.1 - 8.1).
